

- The candidate should bring Facilitation Center (FC) acknowledgement receipt/Provisional allotment letter with college admission receipt and Bonafide certificate, in case the candidate has already taken admission in other college.
- The candidate should bring all original documents for the admission process. If a candidate is unable to produce original certificates at the time of his/her admission on account of admission already secured in other institute, he/she shall produce the **Original Bonafide Certificate** and **Xerox copies of all such documents attested by Head/Principal** of the concerned institute.

- Candidate Should pay fees of Rs.16980/- immediately at the time of admission and such candidates shall be permitted to submit the required original documents on **22nd oct. 2024** till 5.00pm otherwise his/her admission will stand automatically cancelled and fees paid shall be forfeited .
