- The vacant seats after the CAP Rounds shall be filled in by the Candidate from the same Category for which it was earmarked during the CAP. Further if the seats remain vacant then the seats shall be filled on the basis of *Inter- Se-Merit* of the applicants.
- The preference shall be given to Maharashtra State Candidature Candidate over All India Candidature Candidate on the basis of *Inter-Se-Merit*.
- The candidate should bring Facilitation Center (FC) acknowledgement receipt/Provisional allotment letter with college admission receipt and Bonafide certificate, in case the candidate has already taken admission in other college.
- The candidate should bring all original documents for the admission process. If a candidate is unable to produce original certificates at the time of his/her admission on account of admission already secured in other institute, he/she shall produce the **Original Bonafide Certificate** and **Xerox copies of all such documents attested by head/principal** of the concerned institute.
- If already admitted candidate to the other institute gets admission in the institute level round, then he/she will be permitted to submit the required original documents on or before **15th Nov 2025 (4:00 PM)**, failing to this his/her admission will be cancelled and fees paid shall be forfeited.
- **The candidate has to pay prescribed fees (9984/-), Enrollment Fee (300/-) and Online portal fee (1000/-) immediately at the time of admission.**
- Candidate has to cancel his/her earlier admission at his/her own risk and cost. Candidate should cancel previous admission immediately to confirm the allotted admission in this institute.
